• The Board is aware of no ongoing Rocky Ridge Properties litigation.

## OLD BUSINES

• There was no old business.

## NEW BUSINESS

- Ira Marks, a renter of Unit 46, claims his enjoyment of that unit was impaired because of ongoing deck work. He asks compensation from the Association. The Board's policy is that maintenance has priority over renter's tenancy. The Board denies Mr. Marks request.
- Unit 10: Marilyn and Mike Cabak requested that the Board approve their application to add a bathroom to their unit that would cover some of their lower deck space. The Property Committee will make a recommendation to the Board on October 23.
- Unit 21: Juli Ball plans to install new linoleum in her kitchen. She requested that if the linoleum installation is

unsatisfactory, as previous installations have been, and if it is due to a structural problem in her unit, that the Association pay to fix it. Bill Bauder thinks there is no structural damage to the unit. He will re-inspect the sub-flooring when the old linoleum is removed.

- Mrs. Olive has requested installation of playground equipment near the tennis courts. The Property Committee will make a recommendation at the Oct. 23, 2000 Board Meeting.
- Tree Trimming. Bill Bauder asks that the landscape committee pre-approve tree trimming, which is done to improve the health of the trees, but also sometimes improves owners' views, because having a good view is an emotional issue with some owners.
- Pier Rules. Legal committee to draft a pier policy to clarify where boat owners can tie their boats to the pier and for what period of time.
- Beach Use Policy. Review policy at Oct 23 meeting.
- Authorized Bill Bauder to call the pound to pick up dogs at the Ridge that are not on leash, as specified in Article VII, Paragraph 7.7 of the CC& R's
- On July 4<sup>th</sup> underage kids were observed drinking and misbehaving. It is noted that this is a problem for the police.
- Inspectors found faulty flexible flues in Units 5 & 6. These faulty flues are a potential fire hazard and may also release carbon monoxide. Marie will write a letter to the Board containing more detailed information. The Property Committee will make a recommendation to the Board at the October 23 Board Meeting.
- Upgrade Beach Area: Yates will make recommendations at the Oct 23 Board Meeting.
