#### **APPROVAL OF THE MINUTES**

• Approved, as corrected, the minutes of the 10-28-2003 Board Meeting.

#### TREASURER'S REPORT

John Bertone gave the treasurer's report.

#### THE BOARD TOOK THE FOLLOWING ACTIONS:

- Approved the Accountants Review Report, December 31, 2003 and 2002.
   This report, with a covering letter will be mailed to all Association members before the end of April 2004.
- Approved a specific type of outside wall mounted light fixture to replace the existing light fixtures on each condominium. These new fixtures will be installed by Rocky Ridge Maintenance.
- Approved the following amounts for work to be funded by the Replacement Fund:
  - 1. \$9,185 for sealing roads and parking areas. The budgeted amount was \$4,394.
  - 2. \$63,740 for roofing replacement on units 57-60 and units 86 & 87. The budgeted amount was \$56,950.
  - 3. \$21,000 for exterior light replacement.
  - 4. \$2,408 for walkway repairs at unit 16.
  - 5. \$26,500 for deck replacement at units 49-52 and units 65-68.
  - 6. \$12,000 for building repairs.
- Approved the following amount from the Real Property Fund:
  - 1. \$825 for sealing the sales office parking lot. The budgeted amount was \$500.
- Approved an increase in the Association's Automobile Liability insurance to \$3,000,000, instead of \$1,000,000.

- Approved the new location for the 10-18-2004 Board Meeting to be Suite 450, 400 South El Camino Real, San Mateo.
- Approved the completion and final editing of the new by-laws and CC&R's and the assembly of the documentation required for a vote-by-mail ballot. Prior to distribution to the Association Membership, copies of the documentation will be sent to the Board Members for their review and approval.
- Approved the use of coverings for the newly mandated sprinkler backflow devices that look like native boulders, after viewing photographs of a sample installation.

# PROJECT MANAGER BILL BAUDER'S REPORT OF COMPLETED AND ONGOING PROJECTS

- Snow removal went well this year, in part because of a light amount of snow.
- A number of rafter caps have been fabricated and installed.
- Boat buoys have been installed.
- Spring clean up has started.
- · Painting has started.
- Some of the sprinklers have been turned on.
- The beach and tennis courts are being readied for summer.
- Chimney inspection and cleaning is underway.

#### **LEGAL INSURANCE COMMITTEE REPORT**
