TREASURER'S REPORT

• John Bertone gave the treasurer's report.

THE BOARD TOOK THE FOLLOWING ACTIONS:

- Directed Mike Hughes to make the Board requested changes to the new By Laws and CC& R's and to return revised copies to the Board in early May 2005
- Approved Financial Statements and Accountants' Review Report for 2004.
- Approved \$23,000 to replace the decks on units 37-40 and 41-44.
- Approved \$17,000 to repair various RRPOA buildings.
- Approved \$6,275 to seal roads and parking areas.
- Approved \$71,460 to replace the roofs on units 17-20, 70-71 and 78-79.
- Approved \$5,972 to continue application of an overlay to the walkways.

- Directed Bill Bauder to submit an application to the TRPA for a total of 102 buoys adjacent to the RR pier.
- Appointed a Nominating Committee to nominate candidates to fill 4 Board positions for the years 2005-2007. The Committee members: Julie Rollofson, Marshall Shambarger and Bill Trevor were directed to report their nominations to the Board at the next Board Meeting on May 28, 2005.
