- Instructed Ron Benveniste to submit a draft document to the Board describing measures to control dogs and their droppings at Rocky Ridge.

   Bauder to send each owner the bid for repairing his fireplace or chimney.
   Each bid will be accompanied by a letter requesting each owner to have the
   necessary repairs done, either by Alpine Stove and Chimney Service or an
   alternate contractor. Each owner will be asked to notify the Association
   when their repairs are complete.

- The new decks have been installed on units 37-40 and 41-44.
